**SUBJECT: DOGS; LICENSE AND LICENSE TAGS**

Dear Residents,

This letter is a reminder that **ALL** residents with dogs need to license such dog through the Village Clerk's office each year. A maximum of 3 animals (dog & cat combination) per household is allowed. If you have multiple dogs that need licensed, please list each individual dog's name, breed, color, and sex on the attached form. This license is now due for the 2020 year per the below stated Loomis Municipal Code & Nebraska State Statute.

**Chapter 6 Section 6-101 DOGS; LICENSE.**

Any person who shall own, keep, or harbor a dog over the age of six (6) months within the Municipality shall require a license for each such dog from January first (1st) to February fifteenth (15th) of each year. The said tax shall be delinquent from and after February fifteenth (15); provided the possessor of any dog brought into or harbored within the corporate limits or attains the age of six (6) months subsequent to January first (1st) of any year, shall be liable for the payment of the dog tax levied herein and such tax shall be delinquent if not paid within forty-five (45) days thereafter. Licenses shall be issued upon the payment of a license fee of four (\$4.00) dollar for each male dog and spayed female dog and six (\$6.00) dollars for each unspayed female dog, of which, one dollar and twenty-five cent (\$1.25) fee required under section 54-603 (3) RS Neb. is to be paid to the State of Nebraska. Said license shall not be transferable and no refund will be allowed in case of death, sale, or other disposition of the licensed dog. The owner shall state at the time of application is made and upon printed forms provided for such purpose, his name and address and the name, breed, color, and sex of each dog owned and kept by him. *(Ref. 17-526, 54-603, 71-4412 RS Neb.)*

**Chapter 6 Section 6-102 DOGS; LICENSE TAGS**

Upon the payment of the license fee, the Village Clerk's Office shall issue to the owner of a dog a license certificate and a metallic tag for each dog so licensed. The metallic tags shall be properly attached to the collar or harness of all dogs so licensed and shall entitle the owner to keep or harbor the said dog until the thirty-first (31st) day of December following such licensing. All license fees and collections shall be immediately credited to the General Fund. It shall be the duty of the Village Clerk's Office to issue tags of a suitable design that are different in appearance each year. *(Ref. 17-526, 54-603 RS Neb.)*
